Use a power spray that assures good coverage. A driving mist gives best results. Spray under and around all machinery, conveying and processing equipment.

STORED PRODUCTS

To control granary weevil, cadelle beetle, rice weevil, confused flour beetle, Angoumois grain moth, mediterranean flour moth, Indian meal moth, roaches and fleas. Infested stored food products should be fumigated or treated by other effective flods, using an approved product intended for this purpose.

boxcars should be thoroughly sprayed, sufficiently to wet surface, paying attention to cracks and crevices where insects may habor. Spray oid sacked grain heavily to reduce infestations. In addition, direct a light spray to hit all exposed ends, sides and tops of stored bags. Repeat above application as often as necessary.

COCKROACHES, WATERBUGS, SILVERFISH

Control of these insects may be obtained by spraying directly or by thoroughly wetting shelving, baseboard and hiding places.

ANTS

Paint or thoroughly spray surface until wetted wherever ants travel, paying particular attention to nests or runways. Repeat as often as necessary.

BEDBUGS

Spray baseboard, moulding, furniture, loose wallpaper and other points where there

are cracks for the bugs to hide and breed. Spray bed frames, springs and mattresses thoroughly. Repeat as often as necessary.

FLEAS INFESTING PREMISES

These can be controlled quickly and effectively by spraying floors and cracks of infested areas. Fleas lurk in carpets and upholstered furniture.
