DIRECTIONS FOR USE

DRY APPLICATION

Remove push-out portion of shaker cap, then rotate shaker holes so as to allow only the flow of granules that can be spread evenly.

- Moist Soil**—for best results, soil of treated area should be moist at time of application. Rainfall or artificial watering is required to carry the material into the soil before it becomes effective as a root killer.
- Annual Grasses and Weeds**
 - For most effective control, this material should be applied just prior to emergence, or at time when weeds are in seedling stage of growth (1 to 2 inches high).
 - Apply at the rate of 2 pounds per 100 square feet (contents of this package will cover approximately 94 sq. ft.) for seasonal control of most annual weeds and grasses.
- Perennial Grasses and Weeds and for extended control**
 - Apply at the rate of 2 pounds per 50 square feet (contents of this package will cover approximately 47 sq. ft.).
 - Apply to damp soil, preferably at a time when there will be enough expected rainfall to adequately carry the material into the root zone.
- Retreat persistent or spot re-growth as necessary to maintain desired control.
