
Dispose of excess treated seeds by burial in non-crop lands away from water supplies.

### INSECTICIDAL SPRAY

Wash recommended amount of Miller's HEPTACHLOR 50W through screen into partially filled spray tank, or pre-mix in bucket half filled with water and add mixture into nearly filled spray tank. Add balance of water to obtain proper gallonage of completed spray solution. Do not allow mixture to stand. Keep agitator running during filling and spraying operations. Do not combine wettable powders with emulsifiable liquids in the same spray tank unless previous use of the materials being combined has proved to be compatible.

### **SOIL APPLICATIONS** (Pre-plant treatment only)

Pre-plant soil applications may be used for the following crops. Mix the indicated amount of Miller's HEPTACHLOR 50W in sufficient water to assure uniform coverage over soil surface just before last discing when preparing seed bed. Follow application by tilling thoroughly to mix the chemical into the upper 3 to 6 inches of soil.

### FOLIAGE APPLICATIONS

Use 1 to 2 lbs. per acre in sufficient water (200 to 300 gallons) per acre, to insure uniform coverage. Do not make application within 60 days of harvest.

### LAWNS AND QRNAMENTAL TURFS

Ants, Asiatic Garden Beetle, White Grubs-Use 4 lbs. per acre of lawn or turf.

Chiggers, Fleas, Ticks—Use 2 lbs. per acre of lawn or turf.

Apply recommended dosage in sufficient water (50 or more gallons per acre) to insure uniform coverage. Be sure that the chemical has washed from grass into soil area and that grass is dry before allowing children or pets on lawn or turf. Do not feed clippings to livestock, or allow livestock to graze on treated turf.

### SEED TREATER

Miller's Heptachlor 50W seed treatments are for the protection of germinating seeds and seedlings against the insects specified. Heptachlor 50W may be applied as a dust or slurry, and may be combined with commonly used turigicidal seed treatments. Treated seed may be bagged, marked: TREATED SEED. DO NOT USE FOR FOOD, FEED OR OIL PURPOSES, and stored until planting time. Slurry treated seed should not be stacked until it has had a chance to dry.

Mix the required amount with the seed in grain drill or planter, or add to the seed and thoroughly mix in a revolving or drum type treater prior to planting.
