POTATO SEED PIECE TREATMENT FOR PROTECTION AGAINST FUSARIUM SAMBUCINUM

Lilly/Miller 10% DITHANE M-45 DUST is a special fungicide formulation for application on whole or cut potato tubers to protect them from seed-piece decay caused by Fusarium sambucinum.

Use 1 lb. of dust per 100 lbs. of whole or cut potato seed pieces. Apply the dust in a manner such that the entire surface of the seed-piece becomes thoroughly covered with the fungicide dust. Plant seed as soon after treatment as possible.

DO NOT USE TREATED SEED PIECES FOR FOOD OR FEED PURPOSES.

STORAGE AND DISPOSAL - 12 pt.
