

Miller's WHACK is an effective formulation which provides rapid kill of such crawling insects as those listed below, including those resistant to certain chlorinated hydrocarbons and phosphate insecticides.

In addition to the rapid initial kill, Miller's WHACK remains on the treated surfaces and kills insects many weeks after the spray has dried.

DIRECTIONS FOR USE

HOW TO USE

Unlike most pressurized residual sprays, Miller's WHACK provides a pencil-stream spray allowing the user to direct the spray to a distance of 6 feet. Cracks, crevices and hard-to-reach locations can be reached without bending, crawling, or climbing. Spray infested areas until surface is wet, moving the spray stream rapidly to prevent excessive wetting of surfaces and waste of material.

IMPORTANT—Hold Container Only in Upright Position to Spray. Shake well before each use. Direct spray away from face. Point spray away from people, plants, and pets. Do not allow children or pets on treated areas until spray is dry.

USE PRECAUTIONS

Do not apply to rugs, carpets, draperies, wallpaper or similar materials that may be stained. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings.

FLAMMABLE

Do not spray into or near open flame. Do not smoke while using. Keep containers away from stoves, radiators, or other hot surfaces. Do not place in direct sunlight. Temperatures exceeding 120°F. may cause container to burst. Do not puncture or throw container into fire.

DIRECTIONS FOR USE

AS A HOUSEHOLD RESIDUAL SPRAY—Do not apply as a space spray.

Miller's WHACK is a highly effective formulation which provides both rapid and long-lasting control of such insects as Cockroaches, Ants, Crickets, Silverfish. Thoroughly spray into cracks and crevices, around baseboards, under sinks, refrigerators, cupboards, shelves and other places where insects frequent such as in and around garbage containers. For Silverfish, also apply behind shelving, bookcases, and other storage places. Repeat applications as necessary.

FOR OUTDOOR USE—Do Not Spray on Vegetation

WASPS and HORNETS—Apply after dark when all insects have returned to the nest. Spray thoroughly to wet entrance and entire nest. Repeat applications as necessary.

ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLIES, MILLIPEDES, MOSQUITOES AND SOWBUGS—

Spray around window frames, door sills, foundations, porches or other places where insects may crawl before entering home. Spray directly on ant hills and ant runways. Repeat application as necessary.

BROWN DOG TICKS, AND FLEAS—Spray to thoroughly wet cracks, crevices and areas where pets normally lie down. **DO NOT SPRAY ON PETS.** Be sure sprayed areas have dried thoroughly before allowing pets to return. Repeat applications as necessary.
