MIXING DIRECTIONS

Wash recommended amount of Miller's HEPTACHLOR 25W through screen into partially filled spray tank, or pre-mix in a bucket half filled with water and add mixture into nearly filled spray tank. Add balance of water to obtain proper gallonage of completed spray solution. Do not allow mixture to stand. Keep agitator running during filling and spraying operations. Do not combine wettable powders with emulsifiable liquids in the same spray tank unless previous use of the materials being combined has proved to be compatible.

SOIL APPLICATIONS (Pre-Plant Treatment only)

Pre-plant soil applications may be used for the following crops. Mix the indicated amount of Miller's HEPTACHLOR 25W in sufficient water to assure uniform coverage over soil surface just before last discing when preparing seed bed. Follow application by tilling thoroughly to mix the chemical into the upper 3 to 6 inches of soil.

PINEAPPLES — Ants

Use 2 to 4 lbs. per acre in sufficient water (200 to 300 gallons) per acre to insure uniform coverage. Do not make application within 60 days of harvest.

LAWNS AND ORNAMENTAL TURFS — Ants, Armyworms, Cutworms, White Grubs, Asiatic Garden Beetles

Use 8 lbs. per acre of lawn or turf in sufficient water (50 gallons or more) to insure uniform coverage. Be sure that the chemical has washed from grass into soil area and that grass is dry before allowing children or pets on lawn or turf. Do not feed clippings to livestock, allow livestock to graze on treated turf, or dump clippings where livestock may have access to them.
