How do I use this product?

When to use: Use Moss-Out anytime moss becomes a problem in your lawn. Moss grows most vigorously during the warm, rainy periods in spring and fall, but will grow all year round in some shady areas.

Spray as often as needed to keep moss from crowding out lawn grasses.
