For control of Aphids, Twospotted Spider Nites and adult Whiteflies on African Violet, Aralia, Christmas Cherry, Chrysanthemum, Cineraria, Diffenbachia, Fuchsia, Gloxinia, Ivy, Lantana, Neanthe Bella Palm, Petunia, Rose and Snapdragons.
