

Your local agricultural agencies can provide further information on the type of soil in your area and the location of ground water.

STORAGE AND DISPOSAL

Store this product in its original container and keep in a locked storage area out of reach of children and domestic animals. Do not reuse container. Securely wrap container in several layers of newspaper and discard in trash.

LILLY/MILLER SIMAZINE 4G is a herbicide that should be applied before weeds emerge or following removal of weed growth. It controls a wide variety of annual broadleaf and grass weeds when used at recommended rates on Caneberries, Ornamentals and non-crop areas.

Since SIMAZINE 4G enters weeds mainly through their roots, rainfall or irrigation is needed to move it into root zone. Very dry soil conditions and lack of rainfall following application may necessitate shallow cultivation.

EILLY/MILLER SIMAZINE 4G controls many annual broadleaf and grass weeds such as Annual Bluegrass, Annual Ryegrass, Common Chickweed, Crabgrass, Lambsquarters and Pigweed.

DIRECTIONS FOR USE

In each case where a range of dosage rates is given, the lower rate should be used on light soils and soils low in organic matter; the higher rate should be used on heavy soils high in organic matter.

SIMAZINE 4G should be distributed uniformly over the soil surface by means of a cyclone-type spreader. For treatment of small areas, application by hand may be adequate.

After treatment with SIMAZINE 4G, do not plant any crop other than those specified on this label until the following year or injury may occur. Do not rotate with vegetables.

CANEBERRIES (Blackberries, Boysenberries, Loganberries, Raspberries)

Broadcast a single application of 14 to 24 lbs, per 1,000 square feet in the spring before bud break and weed emergence.

TO CONTROL QUACKGRASS, Broadcast 2% lbs. per 1,000 square feet in the fall or split the application, broadcasting 1% lbs. per 1,000 square feet in the fall and 1.4 lbs. per 1,000 square feet in the early spring when Quackgrass is actively growing.

ON NEW PLANTINGS (less than 6 months old), use one-half the above rates. Do not apply when fruit is present.

NON-CROP AREAS

Apply at the rate of 1% lbs. per 215 square feet for long-term control of most annual broadleaf and grass weeds around buildings, along fences, roadsides, and lanes.

TREES, SHRUBS, CHRISTMAS TREE PLANTINGS, AND SHELTER BELTS: Established Trees and Shrubs (see list below)

Broadcast 1% to 1% lbs. per 1,000 square feet in fall or spring to trees and shrubs established at least one year after transplanting. Apply prior to weed emergence.

SHELTER BELTS AND CHRISTMAS TREE PLANTINGS (see list below)

Broadcast 1% to 2% lbs. per 1,000 square feet after transplanting and prior to weed emergence. Remove weed growth before application. Use the same rate for annual maintenance applications in established plantings.

Do not use SIMAZINE 4G on seedbeds or cutting beds. Do not apply to Christmas tree or Shelter Belt transplants less than 3 years of age. Do not apply SIMAZINE 4G more than once a year, except as directed for Quackgrass control.

Apply SIMAZINE 4G to these species of trees and shrubs as recommended:
