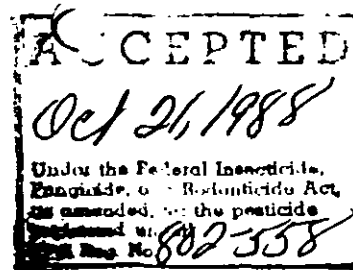
Control moss with MOSS OUT GRANULES. Moss competes with the turf and creates thin areas in the grass. It also causes an excessive buildup of thatch. The best time to control moss is when it is actively growing, usually in the fall or early spring. Application of MOSS OUT GRANULES will cause some greening. For even grass color and more thorough moss control, apply MOSS OUT GRANULES to the entire lawn area.

PREPARE THE LAWN

1. Apply anytime moss is actively growing. Treatment in fall or early spring is most effective.
2. Water lawn thoroughly the day before treatment.
3. Cut grass and remove clippings.

TREAT THE MOSS

1. Apply MOSS OUT GRANULES to lawn area. For heavy infestations use 5 lbs. per 2,000 sq. ft. (2 1/2 lbs. per 1000 sq. ft.). For lighter infestations use 5 lbs. per 2500 sq. ft. (2 lbs. per 1000 sq. ft.) 1 cup weights approximately 11 oz.
2. For spot treatment, sprinkle granules over mossy areas in lawn. Use diagram below as a guide for application rate.
3. Immediately after making application, water treated areas thoroughly.

4. Wait several days and rake out dead moss.

FOR A HEALTHY LAWN

Use Lilly/Miller Super Rich or ULTRAGREEN fertilizers as directed throughout the growing season. A healthy, well-nourished lawn will better resist invasion by moss.

Sow grass seed in bare spots or thin areas with Lilly/Miller Grass Back.

FOR MOSS CONTROL AROUND FLOWERS AND ORNAMENTAL SHRUBS

Apply anytime moss is actively growing. Thoroughly water area to be treated the day before treatment. Sprinkle granules over mossy areas. See diagram for application rate. Immediately after making application, water treated areas thoroughly. Wait several days and carefully rake out dead moss. IMPORTANT: MOSS OUT GRANULES will burn foliage if applied directly to plants. If contact occurs, use a hose to wash material off plants right away.

USE PRECAUTIONS: Keep this product off sidewalks, patios, driveways, etc. This product contains iron for moss control which will stain concrete and painted surfaces. If it comes in contact with concrete surface, sweep off immediately before flushing with water. If concrete is wet when contact occurs, staining may be impossible to prevent.

STORAGE AND DISPOSAL

Store this product in its original container and keep in a locked storage area out of reach of children and domestic animals. Do not reuse container. Securely wrap container in several layers of newspaper and discard in trash.
