

In accordance with Pesticide Registration (PR) Notice 1998-10, the registrant is formally submitting this notification of additional sites of manufacture and revisions to the Storage and Disposal section as indicated on the enclosed Notification (EPA Form 8570-1). Based on the guidance in PR Notice 2007-4, the registrant is amending the Storage and Disposal language to comply with the new container regulations located in 40 CFR Part 156 and is also taking the opportunity to update its label format to be consistent with its recently registered products. That is, many of the optional and/or marketing claims appear on the last page of the label.

Regarding the Storage and Disposal section, the registrant has revised the disposal statement of the product label for the above referenced product to read, "DISPOSAL: **If empty:** Nonrefillable container.
