Dear Mr. Gebken,

On behalf of Avon Products, Inc., we are submitting the enclosed notification for the above referenced product. The Agency is hereby notified that Avon intends to drop the label claim regarding the above referenced product's effectiveness when applied to clothing. In the original EPA conditional approval letter of November 8, 2005, Mr. Joseph Tavano stated:

"4) The claim for use on clothing is being accepted under the following conditions: Data must be submitted to support the efficacy of the product when applied to clothing. A protocol for running the study must be submitted. Once the protocol has been approved, the data must be submitted within one year or you must delete the claim by submitting a label amendment to that effect. You must agree to these conditions."

In a letter dated November 10, 2005, Mr. Andrew Pechko (Avon) agreed to the terms set forth in the Agency's November 8, 2005 correspondence. In conjunction with Insect Control & Research, Inc., the registrant developed a study protocol for evaluation of the efficacy of treated fabric on the repellency of mosquitoes. This protocol was submitted to the Agency on November 9, 2006. Mr. Kevin Sweeney (OPP/RD) subsequently responded in an e-mail noting that the protocol would have to be reviewed by the Human Studies Review Board (HSRB) because the protocol involves the participation of human volunteers as

test subjects. After consideration of the time and effort associated with the HSRB review process, the registrant has elected to remove the claim of product effectiveness on clothing.
