a. "Creates an invisible, unseen, hidden, barrier of protection to repel insects mosquitoes, deer ticks, mosquitoes and deer ticks, gnats, non-see-ums, sand flies and biting midges."

b. "Repels mosquitoes that may carry transmit West Nile virus up to 8 hours."

c. "Repels mosquitoes that may carry transmit West Nile virus for 8 hours."

d. "Repels mosquitoes that may carry transmit West Nile virus."
