Copper reacts rapidly with zinc, and iron. Do not mix in steel or galvanized containers. Plastic containers are recommended.

DIRECTIONS FOR USE

ALGAE CONTROL IN PONDS: Treatment rates and fish sensitivity vary, contact an appropriate state agency for local recommendations for algae control and fish protection. Copper sulfate may be dissolved and applied as a spray to the water surface or crystals may be placed in a cloth bag and pulled in the water behind a boat until dissolved. Good dispersal is essential no matter what method is used. Most algae can be controlled with a single application of 0.1 to 1.0 ppm (.27 to 2.7 lbs. per acre foot of water). Difficult to kill algae may require 3 to 5 applications at daily intervals.

NOTE: Fish kill may result from use of copper sulfate directly or from oxygen depletion as algae mass decays. Do not apply to moving water. Do not treat with over 2 ppm. Do not use water for drinking, livestock watering or swimming for 24 hours after treatment.

ROOT CONTROL IN SEWER CONNECTIONS: Copper sulfate used according to directions will kill roots that clog sewers with no damage to well established trees or shrubs.

Apply 1/2 pound into toilet at night after the final use for the day and flush it down the drain. Repeat until a total of 2 pounds has been applied. If sewer line is completely clogged, some flow must be established mechanically before use of this product. Repeat treatment every 6 months. Never add through sinks or wash basins where thin metal drains might corrode. Do not use in sewer systems with septic tanks, cess pools or lagoons.
