REENTRY STATEMENT

Keep all unprotected persons out of operating areas or vicinity where there may be drift.

Do not allow persons to enter treated areas within 4 days following application unless a long sleeved shirt and long pents or a coverall that covers all perts of the body except the head, hands and feet and chemically resistant gloves are worn. Conspicuously post reentry information at site of application.

Certain states may require more restrictive reentry intervals; consult your State Department of Agriculture for further information. Written or oral warnings regarding use of protective clothing and accidental exposure must be given to workers who are expected to be in treated areas or in areas about to be treated.

DIRECTIONS

Mixers/loaders when mixing and loading this product must wear a long sleeved shirt and long pants or a coverall that covers all parts of the body except the head, hands and feet. Wear chemical resistant gloves, goggles or a face shield and a chemically resistant apron.

Fieldworkers and harvestors must wear chemical resistant gloves if entering treated areas within 4 days. following application. Leather or fabric gloves are not acceptable.

A dust mask must be worn where wiking and loading this product.

During application drily, if from a gradier with a completely enclosed cab, a long sleeved shirt and long legged pants must be were. Chemically resistant gloves must be available in the cab and wom vrhile exiting.

AFTER WORK: Take off all clothes and shoes. Shower using soap and water. Do not wear contaminated clothing. Wash protective clothing and equipment with soap and water after each use. Personal clothing worn during use milet be taundered separately from household articles. Clothing and protective equipment heavily contaminated or dranched with Captan must be destroyed according to state and local regulations.

DIRECTIONS FOR USE *

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

POTATOES (Seed Pieces): Damp Off — Dust at 10 ozs. per bushel cut seed pieces (16 oz. or 1 lb. to 100 lbs. cut seed pieces). Apply in convenient container or by duster attachment over belt. Cut pieces should be treated within 6 hours of cutting. If planting is to be delayed more than 1 or 2 days the treated pieces should be stored for 2 days in open crates before begging. Do not use treated seed for food or feed purposes.

GREENHOUSE BENCH TREATMENT (SOIL): Use 2-21/2 lbs. per 1000 sq. ft. Work into upper 3 or 4 inches of soil before planting. For damp-off and root rot diseases of seedlings and transplants of roses, other shrubs, flowers, and lawn seedbeds. Use the lower rate when climatic conditions are unfavorable for disease development and the higher rate when disease(s) are present or when climatic conditions are favorable for development. If you are unaware of the climatic conditions favorable for specific disease development, you should contact your State Agricultural Extension Service.

NOTE: Only the applicator is permitted to be in the greenhouse during application of Captan to soil. Open vents to greenhouse during application and for at least 1 hour after application.

Workers planting in Captan-treated soil in greenhouses must wear chemical resistant gloves.

ORNAMENTALS: Rose, black spot; Carnation, rust, leaf spot; Chrysanthemums, flower blight — Apply at first sign of disease to give even coverage of upper and lower leaf surfaces. Repeat at 7 to 10-day intervals as necessary. Shorten interval during periods of frequent rain and heavy dew.

STORAGE AND DISPOSAL

PROHIBITIONS

Do not contaminate water, tood or feed by storage, disposal or cleaning of equipment. Open dumping is prohibited.

STORAGE

Keep pesticide in original container. Store in cool, dry place. Protect from excessive heat.
