**STATEMENT OF PRACTICAL TREATMENT**

**IF ON SKIN:** Wash thoroughly with soap and water and change to freshly laundered clothing. See a physician if skin irritation occurs.

**DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.  
 Apply DURSBAN .5G granular insecticide uniformly to home lawns and other ornamental and recreational turf grass areas using any hand or power operated gravity or rotary type spreader designed for application of granular materials. Treat when insects first appear using DURSBAN .5G at the rate of 200 pounds per acre. To help obtain uniform distribution, apply one-half required amount of product in one direction; then apply the balance at a right angle. Immediately after application sprinkle the turf with 1:00 gallon soft water per acre so as to wash the granules into the zone of insect infestation. Consult the following table to determine amounts of DURSBAN .5G and water needed for smaller sized areas. Re-treat as necessary.

**STORAGE AND DISPOSAL**

**PESTICIDE STORAGE:** Store pesticide in the original container in a locked storage area. **PESTICIDE DISPOSAL:** Securely wrap original container in several layers of newspaper and discard in trash. **CONTAINER DISPOSAL:** Do not reuse container. Rinse thoroughly before discarding in trash.
