Dear Mr. Diem:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, is acceptable provided that you make the labeling changes indicated below before you release the product for shipment bearing the amended labeling:

1. Revise the Hazards to Humans and Domestic Animals section to read:

May be fatal if swallowed or absorbed through skin. Causes skin irritation and eye irritation. Do not get in eyes. on skin, or on clothing. Harmful if inhaled. Avoid breathing vapors or spray mist. Do not spray vegatable gardens or other plants used for food purposes.

2. Revise the Environmental Hazards ssection to read:

This pesticide is toxic to birds, fish, and aquatic invertebrates. Birds feeding in treated areas may be killed. Clean up spilled product to reduce exposure to wildlife. Do not apply directly to water. Runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwaters.

3. In the Use Directions - Pests Indoors, revise the last sentence of the Food Areas section by changing "DURSBAN 2-E" to "DURSBAN 4-E."

Submit five (5) copies of your final printed labeling before you release the product for shipment.

## **USE DIRECTIONS - PESTS OUTDOORS**

PEST OF LAWNS, other Ornamental and Recreational Turf Grass Areas and Perennial Turf Grasses Grown Only for Seed: Use DURSBAN 4-E to control the pests listed in the following table by application at the recommended dosages and in accordance with the directions given below. Dilute DURSBAN 4-E in enough water to obtain complete and uniform coverage of pest infested areas and apply as a coarse, low-pressure spray using suitable application equipment. Thoroughly water immediately after treatment to wash the insecticide into the turf, except as noted. For best results, the lawn should be moist at time of treatment.

Ants, Armyworms, Brown dog tick, Chiggers, Chinch bugs, Clover mite, Crickets, Cutworms, Earwigs, Fleas, Grasshoppers, Sod Webworms. Use 3/4 fl. oz. per 1,000 sq. ft. Spray when pests first appear; re-treat when needed. For sod webworms delay watering or mowing the treated area for 12 to 24 hours after treatment. Use 3-6 gals, water per 1,000 sg. ft. White grubs (European chafer and Japanese beetle larvae only). Use 1 1/2 to 3 fl. oz, per 1,000 sg. ft. usually during late July and August or as recommended by your local Agricultural Extension Service specialist for your area. Immediately after spraying, irrigate the treated area with 1/2 to 1 inch of water to wash the insecticide in the underlying soil. 3/4 fl. oz. per 1,000 sq. ft. = 3 3/4 fl. oz. per 5,000 sq. ft. = 1/2 pint per 10,700 sq. ft. = 1 quart per acre.

Area Control of Ticks and Chiggers: Use DURSBAN4-E to control ticks and chiggers infesting non-cropland areas such as roadsides, footpaths and trails, picnic and camping sites, parks and other recreational areas where these pests are present and create a nuisance or possible public health problem. Apply DURSBAN 4-E in water at the rate of 1/2 pint per acre (equivalent to 1/2 fl. oz. per 2,700 sq. ft.) using hydraulic sprayer, mist applicator, knapsack sprayer, or other suitable hand or power spray equipment. Treat low underbrush, grassy areas, weeds and ground surface and debris using enough spray volume to obtain thorough coverage usually 40 to 100 gallons per acre.

ATTENTION (Area Control of Ticks and Chiggers): Do not allow public use of treated areas during application or until spray has dried. NOTE: Mosquitoes coming to rest on areas treated for control of turf and ornamental plant pests will be killed for varying periods of time after treatment depending

on exposure of treated areas to weathering conditions.

TO HELP PREVENT INFESTATIONS OF BUILDING -- For Ants, Crickets, Earwigs, and Sowbugs (pillbugs), treat a band of soil 6 to 10 feet vide around and adjacent to the building, also the building foundation to a height of 2 to 3 feet, where pests are active and may find entrance. Use the same Josage and dilution recommended for control of these pests on turf as shown under PESTS OF LAWNS. Apply as a coarse spray to thoroughly and uniformly well the band area.

#### **ORNAMENTAL PLANTS:**

Use DURSBAN 4-E Insecticide to control aphids, bagworns, cutworms, grasshoppers, leafhoppers, mealybugs, mites, spittlebugs, thrips (exposed), and while hes ' on flowers, shrubs, vines, shade and flowering trees and evergreens found to be infested with these pests. Dilute DURSBAN 4-E Insecticide with water according to following directions and apply using a suitable hand or power spray equipment in a manner to provide complete and uniform coverage of infested plants (A. o. c. overspraying to the point of excessive runoff. Treat when pests appear and repeat at 7 to 10 day intervals, if needed. NOTE: Do not use on azaleas, can it lies, ' poinsettias, rose bushes or variegated ivy because of possible injury to these plants. .,

PESTS CONTROLLED: Aphids, Bagworms, Eastern Tent caterpillar, Fall webworm, Grasshoppers, Mites, Orangestriped oakworm, Spiillabugs, White flies, Yellow necked caterpillar. Per 3 gallons use 0.25% fl. oz.; per 10 gallons use 0.8 fl. oz.; per 100 gallons use 1/2 pint.

PESTS CONTROLLED: Cutworms, Lealhoppers, Mealybugs, Mimosa webworm, Redhumped caterpillar, Thrips (exposed). Per 3 gallors use 1.5 fl. oz ; per 10 gallons use 1.6 fl. oz.; per 100 gallons use 1 pint.

PESTS CONTROLLED: Ash borer, Lilac borer, Scale crawlers, (Oak lecanium, Pine needle, Tea, White peach). Per 3 gallons use 1.0 fl. oz.; per 10 gallons use 3.2 fl. oz.; per 100 gallons use 1 quart.

# USE DIRECTIONS - PESTS INDOORS

GENERAL INFORMATION: Use to control the pests indicated in the areas listed below by application as a 0.25% or 0.5% Chlorpyrifos (Dursban 4-E) spray. Use the 0.25% spray to control light infestations and the 0.5% spray to quickly reduce heavy infestations or as directed. To prepare the spray, dilute with water or with a suitable base oil\* as shown in the following SPRAY DILUTION CHART. Repeat the treatment as needed. "Use only deodorized kerosene for oil-based sprays to be applied in food handling establishments.

Note: Where quick knockdown and or "flushing action" is desired, dichlorvos (DDVP) or pyrethrins may be added to the spray mixture. For best results, use dichlorvos at a concentration of 0.25% in both water and oil-base sprays. Consult labeling for the dichlorvos or pyrethrins product used to determine the amount needed to give the desired spray concentration. Also read and observe all use and handling precautions for these products. Do not use in combination with dichlorvos (DDVP) or pyrethrins for treatment of food areas of food handling establishments.

#### - CRĂCK AND CREVICE TREATMENT----

FOOD HANDLING ESTABLISHMENTS - Places other than private residences in which exposed food is held, processed or served. (Including but not limited to Restaurants, Grocery Stores, Bakeries, Bottling Plants, Canneries and Grain Mills).

FOOD AREAS – APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY. Serving areas (when food is exposed and facility is in operation also would be considered a food area). Refer to above chart for dilution rates. Apply in small amounts directly into cracks and crevices using sprayer capable of delivering a pin stream of insecticide in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls; equipment legs and bases; conduits, motor housing junctions or switch boxes. Do not use water dilution sprays in conduits, motor housings, and electrical switch boxes. Prior to oil dilution application de-energize electrical equipment. After applications allow time for oil to evaporate before starting motors or placing switches in the on position where the following insects may hide -- COCKROACHES, ANTS, CRICKETS, FIREBRATS, SILVERFISH, SPIDERS. Care should be taken to avoid depositing onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces. For ants apply to ant trails and where they may find entrance. Repeat treatment as needed but not more than once every 7 days in restaurants and similar food service establishments or more often than once every 14 days in other types of food handling establishments. DURSBAN 2-E may be applied after 2 days from last treatment but emergency use should be limited to once per month.

#### APPLICATION WITHIN RESIDENTIAL BUILDINGS:

Including Homes and Apartment Buildings and Within Nonfood Areas of Industrial, Institution, and Commercial Buildings Including Hospitals, Stores, Manufacturing Plants, and Warehouses: For Spot Treatment Only – Apply as a coarse spray or with a paint brush to localized areas where cockroaches (including strains resistant to certain other insecticides) ants, clover mites, crickets, firebrats, silverfish, and spiders are found or normally occur including dark corners of rooms and closets; cracks and crevices in walls; along and behind baseboards, beneath sinks, stoves, refrigerators, and cabinets; around plumbing and other utility installations. NOTE: A period of 4 to 7 days is normally required for maximum effect on cockroaches. For control of carpet beetles, thoroughly apply a 0.5% spray as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and 'urniture, in closets and on shelving, and wherever else these insects are seen or suspected. For control of brown dog ticks, thoroughly apply a 0.5% spray as a spot treatment of infested areas, such as petbeds and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet areas. DO NOT TREAT PETS WITH THIS PRODUCT. Treat pets additionally with a product registered for animal application.

Attention (Pests Indoors): Do not apply water-based sprays of this product in conduits, motor housings, junction and switch boxes or other electrical equipment because of possible shock hazard if there is need to treat such areas use only oil-based sprays. Prior to application de-energize electrical equipment. After application allow time for oil to evaporate before starting motors or placing switches in the "on" position. Do not use in poultry houses or other animal buildings. Do not allow spray to contact food, feedstuffs, and water supplies. Thoroughly wash dishes and food handling utensits with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying
