### **DIRECTIONS FOR USE:**

Always use a good insecticide sprayer designed for the specific application such as Crain Commander Fogger. Spray into space to kill flying insects. Spray surfaces as directed to kill crawling insects. Follow directions for best results.

TO KILL ROACHES, WATERBUGS, SILVERFISH, CRICKETS, SPIDERS, BROWN DOG TICKS, CENTIPEDES, FLEAS: Apply directly into infested areas and onto infested surfaces. This drives insects out for contact with the killing mist. Where possible, spray heavily all cracks, crevices, under cabinets, sinks, around drains, floors, and any place where these pests crawl, nest, or breed. Repeat weekly, or as needed to maintain lasting control.

TO KILL ANTS: Spray along ant trails, into nests, porch landings, building supports, foundations, or the sides of the building up to window level. Spray into all openings from which the ants emerge. Repeat as necessary.

TO KILL FLIES, MOSQUITOS, GNATS, WASPS: Close room or ware-house and shut off all ventilating systems. Use a spraying device similar to the Commander Fogger or use sprayers that produce a fine spray. Use a dosage of one to two fluid ounces of Dual Fogging and Spray Insecticide per 1,000 cubic feet of room space. Discharge spray mist into corners, under furniture, and upward in center of room. Keep room closed for at least ten minutes. Do not remain in treated areas. Ventilate the area after treatment is completed. Sweep up and destroy fallen insects. Repeat as necessary for control.

TO KILL CLOTHES MOTHS: Brush and air garments. Spray closet walls, floor, thoroughly. Spray clothing completely under lapels, pleats, seams. Keep sprayer at least one foot away. Repeat in thirty days.

TO KILL BEDBUGS: Spray both sides of mattress liberally, esterally tufts and seams. Dismantle bed, spray joints, cracks, etc. Spray walls, baseboards, window trim.
