**DIRECTIONS**

**STORAGE PROTECTION:** Thoroughly clean containers in which garments or materials are to be stored. Grease spots and dust should be removed from garments or materials. Place liberal quantity of para underneath, between and on top of clothing, woolens, furs, draperies, rugs, blankets, etc. On top layer use extra liberal supply, at least one pound to each 100 cubic feet. Close containers as tightly as possible. When containers are opened, use additional para. Sprinkle generously on top and under cushions of all upholstered pieces.

**VACUUM CLEANERS:** Thoroughly clean garments, furniture, rugs and all materials before using para. Fill the container attached to the electric vacuum with para. Then with your vacuum cleaner force the gases from the para (as well as the para) into crevices, cracks, corners and garments, also on top bottom and edges of rugs. Keep fumes tightly confined for at least two or three days. To confine fumes in furniture or rugs, completely cover them with newspaper or heavy wrapping paper. Be sure paper is securely tied. To confine fumes in clothes closets be sure and keep door closed, and fill up with newspaper or wrapping paper any opening underneath door or any other large opening for at least several days.

Overcomes musty, perspiration and tobacco odors in garments; and in tightly closed containers also prevents mildew.

Linens, cottons, as well as rayons, nylons and other synthetic materials similarly stored, will be protected against damage by silverfish.

Leaves no clinging odor. Follow directions and garments and materials will have moth protection.

In all cases repeat treatment as often as necessary.

**CAUTION** Avoid prolonged breathing of vapor and spray. Avoid contact with eyes. Rooms with treated furniture should be well ventilated before occupancy. Do not use para with naphthalene or with camphor. Do not use with styrene plastic hangers or boxes.
