TANK MIXES

Do not tank mix with any herbicides. Do not tank mix with any insecticide, fungicide or miticide whose label indicates that it should not be used with oil. APPLICATION INSTRUCTIONS

The target pest must be completely covered with spray. Oil residue on the plant surface often acts as a feeding and ovipositioning deterrent. However, the primary target is the pest itself as oil is a contact pesticide. Spray only when the temperature is above 40°F and there is no danger of freezing.

DILUTE APPLICATIONS defined as the number of gallons needed to completely cover all the tree surfaces, but not to the point of runoff. For most tree fruits this can be as much as 300-400 gallons per acre or as low as 100 gallons per acre for smaller trees. Dilute applications ensure the best coverage

CONCENTRATE APPLICATIONS (usually 45 to 125 gallons spray per acre) may reduce coverage and effectiveness. Concentrate application includes the use of low volume (from 10 to 100 gallons spray per acre) sprayers. A concentrate application can provide satisfactory results as long as the spray unit is properly engineered, calibrated and operated. Speed of travel for ground application is extremely important. Tractor speed fron 1 M.P.H. to 4 M.P.H. is recommended depending on crop, crop size and target pest.

Low volume applications of Sunspray 11E will require approximately the same amount of oil per acre as dilute sprays but applied with much less water. Spray oil calculations should be based or no run off of the oil phase of the mixture.

AERIAL A PPLICATIONS Use only as an emergency application when soil conditions do not permit regular ground application. Apply quantity of product shown for each listed crop for control of listed insects in sufficient water to make a minimum of 20 gals, dilute spray per acre.



GENERAL RECOMMENDATIONS FOR APPLICATION TO ALMONDS, APPLES, APRICOTS, CHERRIES, PEACHES, NECTARINES, PEARS, PLUMS AND PRUNES.

Completely cover all tree parts to achieve adequate control. Oil alone will control low to moderate infestations. Oil may be combined with other compatible insecticides for controlling higher scale infestations or to achieve better control of Peach Twig Borer. If 11E is combined with another insecticide use the lowest rate of 11E stated for a selected application (dilute, concentrate or aerial). We recommend consulting the local pest management guidelines for more details as to the rates and times of application for your specific location.

SHADE TREE AND ORNAMENTAL PLANT RESTRICTIONS

Oil removes the glaucous (blue) bloom from such evergreens as Colorado Blue Spruce and Koster Spruce. Do not spray walnut foliage. Use lower dosage on oil sensitive plants such as Chamaecypris, Cryptomeria, Japanese Holly. Juniper, Spruce and Smoke tree. Tendency towards sensitivity: Red Cedar and Douglas Fir. Use with caution and reduce dosage for dormant application on Sugar Maple and Red Bud. Do no spray when buds have fully opened and shoot elongation is occurring.

All horticultural oils interfere with or slow plant transpiration and respiration during the period of evaporation.
