May be used on day of harvest. OKRA: To control corn earworm, stink bugs. May be used on day of harvest. CUCUMBER, SQUASH, PUMPKIN, MELONS: To control pickleworm, melonworm, cucumber beetles, flea beetles, leafhoppers, squash bugs. May be used on day of harvest.

LEAFY VEGETABLES and ROOT CROPS such as CARROTS, CHINESE CABBAGE, COLLARDS, DANDELION, ENDIVE, BEET, HORSERADISH, KALE, LETTUCE, MUSTARD GREENS, PARSLEY, PARSNIP, RADISH, RUTABAGAS, SATSIFY, SPINACH, SWISS CHARD, TURNIP: To control flea beetles, leafhoppers, harlequin bug, six-spotted leafhopper (aster yellows vector), corn earworm, armyworms, cabbage loopers, imported cabbageworms, tarnished plant bugs, stink bugs. May be used on day of harvest of carrots, up to 3 days before harvest of other root crops and head lettuce, and up to 14 days before harvest of other root crops and head lettuce, and up to 14 days before harvest of other root crops.

FLOWERS: To control Japanese, blister, flea, and June beetles, boxelder, mealy, lace and plant bugs, leafhoppers, leatcollers, psyllid, rose aphid and exposed thrips. NOTE: Does not control spider mites, but is compatible will all common miticides.

SMALL FRUITS: Cover upper and lower surfaces of leaves thoroughly. Cane berries such as: BLACKBERRY, BOYSENBERRY, DEWBERRY, LOGANBERRY, RASPBERRY to control Japanese beetle, leafrollers, leafhoppers, raspberry aphid. Can be used up to 7 days before harvest. STRAWBERRIES for spittlebugs, leafhoppers and weevils. To be used up to 1 day before harvest.

LAWNS: Dust using 1 lb. per 275 sq.ft. for control of ants, chinch bugs, earwigs, fall armyworm, fleas, leafhoppers, mosquitoes, sod webworm (lawn moth), millipedes. For best results mow lawn and apply after watering or rain. Repeat in 2 to 3 weeks if necessary.

DOGS AND CATS: Dust entire animal, avoiding eyes, to control fleas and ticks. Rub thoroughly into skin. Repeat at weekly intervals if needed. Also, dust in and around sleeping quarters, kennels, and doghouses. Be sure to force dust into cracks and crevices. Repeat as necessary. Avoid treatment of puppies and kittens less than 4 weeks old. Do not use on pregnant pets. Do not allow recently treated pets on carpet as staining may occur.
