Lawn Renovator is a non-selective grass and weed killer. Foliage is killed upon contact with the spray material. Kill is faster when plants are young and actively growing. Contains a wetting agent for more effective foliage coverage. This product becomes inactive upon contact with the soil, so it may be used around trees and shrubs where roots might be damaged with other chemicals. Repeat applications may be necessary for complete control of perennials. • This product will only top-kill perennials.

,L'AWN RENOVATING DIRECTIONS:

Mow lawn to approximately 1 inch depth before treatment. Mix 10 fluid ounces of this herbicide per gallon of water. Mix thoroughly. This should cover approximately 225 square feet (10' x 22-½'). Or mix 1 pint in 1½ g-llons water to cover 337 square feet (10' x 33.7'). Apply preferably on a warm, sunny day. Bermuda grass and other deep-rooted perennials may require a second treatment in 5 days. When no green areas remain, rake off all loose plant material scarifying bare spots. About five days after last treatment, water thoroughly and then seed at the rate recommended for new lawns. Seed must be raked into soil. Keep seeded areas well watered.

DIRECTIONS FOR USING AS WEED AND GRASS KILLER IN CERTAIN OTHER AREAS:

For general weed control on drainage ditchbanks and rights-of-way, along sidewalks, driveways, fences, around buildings and ornamentals, and similar non-crop areas. Mix Lawn Renovator thoroughly in a sprinkling can or pressure spray tank. Use at the rate of 5 to 10 fluid ounces per gallon of water. Apply just to the runoff stage covering foliage thoroughly. Repeat in 5 days if green areas remain.

***CAUTION:**

Keep children and pets off treated areas until after rain or sprinkling following treatment. Do not track from treated to untreated areas. Harmful if swallowed, Avoid contact with skin, Avoid breathing spray mist. Wash hands after using, Avoid storing near feed or food products.

Do not graze treated areas to livestock.

Do not contaminate waters used for domestic consumption, animals, fish, or irrigation purposes.

Do not apply directly, or allow spray to come in contact with foliage, green bark, grafted unions or scuffed, damaged, or broken bark when spraying around trees and ornamentals.

Container Disposal: Do not reuse empty container. Wash thoroughly with a water and detergent solution, crush if possible, and discard in a safe place.


