Dear Ms. Hodge:

The amended labeling referred to above is acceptable provided you adhere to the following conditions:

1. Make the following changes to your labeling:

a. Replace the precautionary statements with the following:

Caution: Keep out of reach of children. Harmful if swallowed. Avoid contact with skin. Avoid breathing spray mist. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Wear protective clothing when handling or applying this product, including long pants, long-sleeved shirt, shoes plus socks, and chemical-resistant gloves. Do not allow people or pets to enter treated areas until after sprays have dried.

b. In the "Environmental Hazards" section, replace "disposal of wastes" with "disposing of equipment washwaters or rinsate."

c. In the Storage and Disposal section, add "Do not contaminate water, food, or feed by storage or disposal" immediately prior to "Storage:".


2. Submit one copy of final labeling of this labeling for this product.

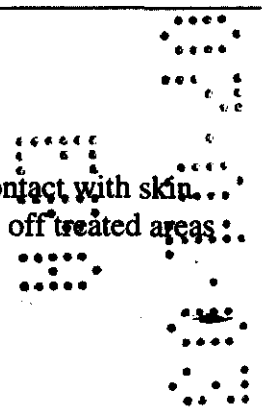

FIRST AID

STORAGE AND DISPOSAL

STORAGE: Store in a locked storage area out of reach of children and domestic animals. Store in original container.

DISPOSAL: If empty: Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place unused product down any indoor or outdoor drain.

GENERAL INFORMATION: Green Light Liquid Edger is a special formulation designed to provide the homeowner with an exclusive, fast-acting control of unwanted grass and weeds in turfgrass and around ornamentals. May be used right in and around desired plants with no root damage. Kills on contact only.

SHAKE WELL BEFORE USING---APPLY DIRECT FROM CONTAINER

WHERE TO APPLY: Green Light Liquid Edger eliminates the need for hand trimming. Use along the edges of the lawn to stop grass from creeping into sidewalks, flower beds, bushes, shrubs, tree wells, sprinkler heads and similar areas. Green Light Liquid Edger will stop grass growth. Respray only when new growth appears. Few treatments are needed during the growth season, with the effect of each respray lasting longer. It will not damage desired plantings, either through misting or root absorption. To avoid drift that may injure desirable plants, do not apply during windy weather.

HOW TO APPLY: Shake well. Remove cap leaving spray top and spray directly to grass blades until wet. Not necessary to soak. A neat, straight edge may be easily and quickly applied---apply direct from container. **COVERAGE:** Approximately 3,000 feet of 2 inch edging.

USE FOR SPOT WEED CONTROL: Use as is for spot weed control of annual grasses and weeds in established turfgrass and around ornamental plants. Treat weeds in early growth stages just to the point of spray runoff. Best results obtained when applied on sunny days and temperature is above 70 F. Kills weeds in 12 to 24 hours. Do not allow spray to contact desirable plants. Respray when new weed growth appears.
