GENERAL INFORMATION

WEED AWAY, a water soluble liquid, mixes readily with water to be applied as a foliage spray for the control or destruction of most herbaceous plants.

This product moves through the plant from the point of foliage contact to and into the root system. Visible effects on most annual weeds occur within 2 to 4 days but on most perennial weeds may not occur for 7 days or more. Extremely cool or cloudy weather following treatment may slow down activity of this product and delay visual effects of control. Visible effects are a gradual wilting and yellowing of the plant which advances to complete browning of above ground growth.

Do not treat weeds under poor growing conditions such as drought stress, disease or insect damage, as reduced weed control may result. Reduced results may also occur when treating weeds heavily covered with dust.

Rainfall or irrigation occurring within 6 hours after application may reduce effectiveness.

ATTENTION - AVOID DRIFT. EXTREME CARE MUST BE USED WHEN APPLYING THIS PRODUCT TO PREVENT INJURY TO DESIRABLE PLANTS AND CROPS. Do not allow the herbicide solution to mist, drip, drift, or splash onto desirable vegetation since minute quantities of this herbicide can cause severe damage or destruction to the crop, plants, or other areas on which treatment is not intended.

It is a violation of Federal Law to use this product in any manner inconsistent with its labeling. Read the entire label. For weed and grass control in lawns and non-food areas.

MIX SPRAY SOLUTIONS OF THIS PRODUCT AS FOLLOWS:
8 OUNCES (16 TABLESPOONS) IN 1 TO 2 GALLONS WATER TO TREAT 500 SQ. FT.
16 OUNCES (1 PINT) IN 2 TO 4 GALLONS WATER TO TREAT 1000 SQ. FT.
Mix well and apply on a spray-to-wet basis. Spray coverage should be uniform and complete. Do not spray to point of runoff.

WEED AWAY is applied as a foliage spray for the control of most grasses, weeds and brush. Use in and around flower beds, walks, driveways, alleys and around trees and shrubs. Use as a spot spray only to individual weeds in lawns.

Avoid contact with desirable vegetation. Contact of the herbicide with desirable vegetation may result in damage or destruction.

NOTE: Be careful when spraying weeds not to spray foliage or green bark of plants or trees and blades or runners of desirable lawn grasses. Do not allow children and pets in treated area until dry. This prevents tracking spray to desirable vegetation.

Treated areas can be reseeded or planted 7 days after application.
