HAZARDS TO HUMANS AND DOMESTIC ANIMALS

STATEMENT OF PRACTICAL TREATMENT

DISPOSAL: Do not reuse empty container. Wrap empty container in several layers of newspaper and discard in trash.

GENERAL INFORMATION: Green Light Grass & Weed Killer kills unwanted grass and weeds in cracks of walks, driveways, and patios. Spray edges along warks, driveways, patios, around buildings, shrubs and flowerbeds, under fences and other areas where weeds are not wanted.

HOW TO APPLY: SHAKE WELL BEFORE USING. Green Light Grass & Weed Killer is ready-to-use. No mixing necessary. Turn adjustable spray nozzle to spray position. Use just enough spray to completely cover foliage of the target weed. It is not necessary to soak weed. Kills on contact only. Accidental spotting of desirable plants may be washed off or pruned at time of treatment. Reapply to perennial weeds when green color reappears. for best results, apply to weeds in early growth stage.
