(FEATURES, CLAIMS & USES:)

Divosan Forte is recommended for use on pre-cleaned food contact surfaces such as food process equipment, pipelines, tanks, vats, fillers, evaporators and pasteurizers in diaries, breweries, (carbonated) beverage, wineries, bottled water, juice and other food processing plants (facilities). This product is an effective sanitizer when the sanitizing solution is prepared in water up to 500 ppm hardness calculated as CaCO₃.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Sanitizing Food Contact Surfaces:

- 1. Clean equipment immediately after use.
- 2. Remove gross food particles by flushing with water or scraping.
- 3. Wash with a detergent solution.
- 4. Rinse with potable water until equipment is cooled to less than 100° F.
- 5. Sanitize by metering this product directly from the original product container into a makeup tank by use of a(n) (JohnsonDiversey) automatic dispensing system. Dilute 1 fl. oz. of product in 5.8 gallons of water providing 200 ppm peroxyacetic acid.
- 6. Circulate the sanitizer solution for at least 2 minutes to thoroughly contact all surfaces.
- 7. Drain sanitized surfaces completely before restarting processing.
