USE	SHRUB/TREE	DOSAGE	APPLICATION
Pastures, rangeland and non-cropland areas such as fence rows, roadways, waste land and similar areas.	Eastern Persimmon	Use 1 level teaspoonful of BANVEL® 10% granules per inch diameter of the trunk of the plant. (Example: Use 3 teaspoonfuls for a tree with a trunk 3 inches in diameter.)	Scatter the granules evenly on the ground within 6 inches of the trunk. Apply BANVEL® granules anytime after buds start to open and before the leaves and branches stop growing in the summer.
	Creosotebush Yarbush	Use 1 heaping tablespoonful of BANVEL® 10% granules per 4 feet diameter of canopy.	Make application just prior to or in the early part of the rainy season. Scatter the granules uniformly under the canopy of the shrub.
	Salt Cedar	Use 50 to 100 pounds of BANVEL® 10% granules per acre (5 to 10 lbs. dicamba acid equivalent).	Make application just prior to or in the early part of the rainy season. Apply BANVEL® granules uniformly over the area to be treated.
