DIRECTIONS

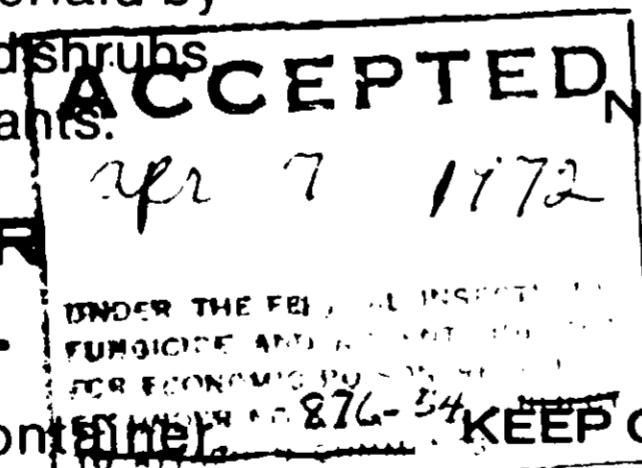
Apply in the spring or fall to established lawns (not pastures) and golf course fairways, aprons, tees and roughs at the rate of 10 pounds per 2000 square feet. May be used on newly seeded lawns after the second cutting in the spring. For best results, make application to moist grass and do not mow or water for 24 hours after application.

Make one application per year for control of dandelion, plantain, chickweed, knotweed, clover, sheep sorrel, henbit, stitchwort, buckhorn, dogfennel, mustard and other broadleaf weeds.
