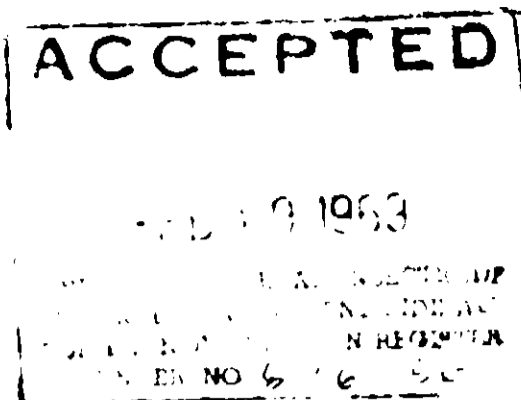

DESCRIPTION

Velsicol THIRAM 75 is a 75% THIRAM formulation in wettable powder form. THIRAM 75 may be applied for disease prevention and control in water, or may be combined with Velsicol 2-1 fungicide to broaden the disease control spectrum and increase the safety factor of the mercurial fungicide.

**DIRECTIONS FOR USE ON TURF
(NOT PASTURES) (PREVENTATIVE)**

Disease	Rate of Application Per 1000 Sq. Ft.	Amt. of Water Per 1000 Sq. Ft.	Interval of Applications	Recommended Rate of Velsicol 2-1
Brown Patch	3 ounces	5-10 Gal.	5-7 Days	½ ounce
Dollar Spot	3 ounces	5-10 Gal.	5-7 Days	½ ounce
Snow Mold	8 ounces	5-10 Gal.	Late Fall	

For curative treatment of Brown Patch or Dollar Spot, increase rate to 4-½ ounces of THIRAM per 1000 sq. ft.

Do not water or mow grass after treatment until fungicide is thoroughly dry, preferably 24 hours after application.

Do not permit animals to feed or graze on treated areas. Do not use grass clippings from treated areas for food or feed purposes. Apply this product only as specified on this label
