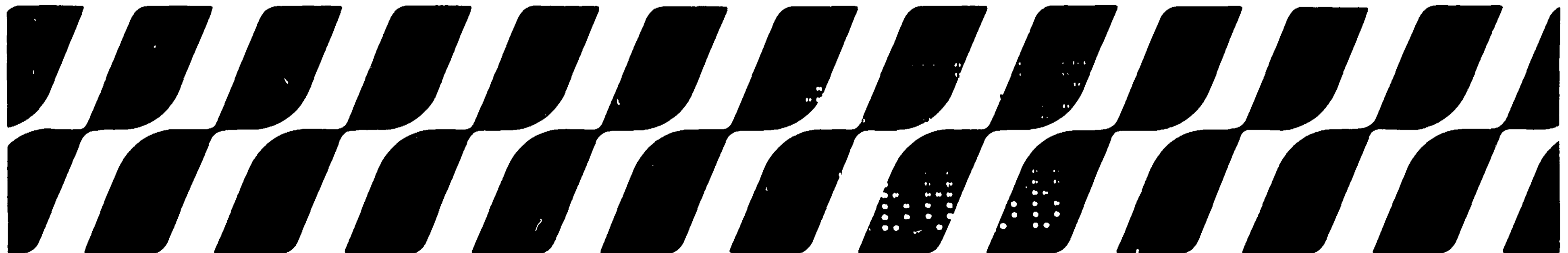

### DIRECTIONS FOR USE

CROP	INSECTS	lb./acre Belt 5% Dust	lb./acre Technical Chlordane	DIRECTIONS
COTTON	Boll weevil	20	1	Make application at 4 to 5-day intervals. Do not apply after bolls open.
	Cotton fleahoppers Darkling beetle Fall armyworm Tarnished plant bug Thrips	10-30	0.5-1.5	Apply at cotton treating schedules. Do not apply after bolls open.
	Grasshoppers	20	1	Do not apply after bolls open.
TOBACCO	Hornworms	20-40	1-2	Repeat as necessary.
CITRUS	Grasshoppers	30-40	1.5-2	Apply to ground cover. Do not apply when fruit is on tree. Do not allow dairy animals to graze in treated groves.

**NOTE:** Application to greenhouse soil is limited to areas where nonfood crops are grown.
