## **DIRECTIONS FOR USE**

Use Promar Tracking Powder for house mouse and rat control only in areas where there is no possibility of food contamination or contamination of surfaces that come in direct contact with food. Place Promar Tracking Powder in locations which are not accessible to children, pets, wildlife and domestic animals, or in tamperproof boxes.

Place Promar Tracking Powder in mouse and rat runways or avenues of travel so that dust is picked up when mice and rats encounter the powder.
