The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed: below. One copy of the finished labeling must be submitted prior to releasing the product for shipment.

On the first page, delete "**alternate label". It's not clear to what this footnote refers.

On the second page, revise the second sentence under the heading "FOR CRACK AND CREVICE" as follows:

Equipment capable of delivering a pin stream should be used for points between different elements of construction...

On the second page, under "AIRCRAFT" delete the following sentence "Stop ventiliation for a period of not less than 3 minutes" and replace it with "Turn off ventilation systems."

On the second and third pages, delete the following language, as it is unclear to what it refers:

Directions for use by DOD personnel only for public health, plant protection and quarantine pests"

To Kill Exposed Forms of Confused Flour Beetles, Saw-toothed Grain Beetles, and Rice Weevils: Find and destroy infested package goods, remove all other items from pantry. Spray the shelves to kill any of the named insects present. Place clean paper on the shelves and return packages after shelves have dried. Repeat as necessary.

To Kill Sowbugs, Centipedes, Silverfish, Firebrats and Spiders: Contact as many insects as possible with the spray. Special attention should be paid to cracks, crevices, hidden surfaces under sinks, behind stoves and refrigerators. To Kill Fleas and Brown Dog Ticks: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as necessary. Do not spray animals. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Also, treat dogs and cats with a registered flea and tick control product before allowing them to enter treated area. 
To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas and Carpet Beetles: Apply spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used points between different elements of construction, between equipment and floors, openings leading to voids nollow spaces in walls, equipment legs and bases where the above listed insects hide.

AIRCRAFT(Cargo storage areas only):

To kill flying Insects (mosquitoes, houseflies, and Caribbean Fruit Flies): Use while the aircraft is empty of passengers and on the ground prior to take off and after landing. Before takeoff and after loading of all cargo is complete, close all doors, hatches and ventilation openings. Stop ventilation for a period of not less than 3 minutes. Spray 10 grams (10 seconds) per 1,000 cubic feet. Push button to spray. Move arm from side to side in a sweeping motion. After spraying is complete, open doors and hatches, turn on ventilation system and ventilate for 30 minutes with fresh air prior to boarding the aircraft with passengers. After landing, remove all passengers, close all doors, hatches and ventilation openings and reapply insecticide as instructed above.

IN BUILDINGS VANS, SHIPS, AND IN TENTAGE:

Ten seconds of spraying is ample for each 1,000 cubic feet (10 feet x 10 feet x 10 feet). Keep treated area closed at least 30 minutes. Ventilate area before re-entry. Repeat as necessary.
