Dear Mr. Stratmeier:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

General Comment(s):

1. The new ABN requested as part of this label amendment, "Black Knight™ Habitat™ Treatment," is acceptable.
2. Revise the statement "**CAUTION: SEE ADDITIONAL PRECAUTIONARY STATEMENTS ON BACK**" to read "**CAUTION: SEE ADDITIONAL USE RESTRICTIONS & PRECAUTIONARY STATEMENTS ON BACK.**"

Directions for Use section comment(s):

3. Revise the existing subsection title "**USE RESTRICTIONS**" to read "**USE RESTRICTIONS & PRECAUTIONS.**"
4. To facilitate inclusion of missing comments which were included in the SAL dated November 3, 2006, for this product (copy enclosed), make the following changes to the "**TO KILL SNAKE MITES**" subsection of this revised label:
  - Within the 2<sup>nd</sup> paragraph of this subsection, revise the 4<sup>th</sup> sentence by inserting the word "every" immediately following the word "than."
  - Within the 2<sup>nd</sup> paragraph of this subsection, insert the following text immediately following the last sentence: "If the snake must be sprayed, use only a registered product labeled for spraying on snakes."

Storage and Disposal section comment(s):

5. Revise the existing "**STORAGE:**" subsection to read "**PESTICIDE STORAGE:** Store in a dry, cool (preferably locked) area, away from heat or open flame, in a place that is inaccessible to children and animals."
6. To facilitate inclusion of language from PR Notice 2007-4, revise the existing "**DISPOSAL:**" subsection to read "**CONTAINER DISPOSAL:** Do not puncture or incinerate! *If empty:* Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. *If partly filled:* Call your local solid waste agency for disposal instructions."

Precautionary Statements, Hazards to Humans & Domestic Animals subsection comment(s):

7. Revise the 4<sup>th</sup> sentence to read "Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet."



- 8. Revise the 2<sup>nd</sup> sentence within the "HOT LINE NUMBER" subsection to read "For additional information on this pesticide product (including health concerns, medical emergencies or pesticide incidents), you may call 1-800-xxx-xxxx."<sup>1</sup>

#### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS**

**USE RESTRICTIONS: FOR INDOOR USE ONLY.** Do not use in commercial food processing or preparation areas. Do not use where food may be exposed or is commercially processed. In the home, food contact surfaces and equipment must be washed with an effective cleaning compound followed by a potable water rinse after using this product. **DO NOT USE IN AIRCRAFT CABINS.**

#### TO KILL COCKROACHES AND ANTS

Contact as many insects as possible with the spray. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators, and food storage areas. To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

#### TO KILL SNAKE MITES

Use only in snake aquariums, habitats or cages. Remove snake from infested area. Remove drinking water. Holding sprayer 6 inches (15cm) above the floor of the enclosure, spray along length of aquarium, habitat or cage as directed in the rate table:

| Size of Snake Habitat | Application Rate |
|-----------------------|------------------|
| 2.4 Gallons           | 2 seconds        |
| 5 Gallons             | 4 seconds        |
| 10 Gallons            | 8 seconds        |

Spray Surfaces until damp. Return snakes only when the area has been ventilated and the surfaces are dry. Do not spray directly on snakes. Do not spray more often than 30 days. Do not use for other reptile habitats, aquariums or cages.

#### TO KILL FLEAS AND BROWN DOG TICKS

Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of the floors. Allow treated habitat to dry before allowing pets to re-enter. Repeat as necessary. Do not spray animals. Replace bedding with clean, fresh bedding after treatment. Treat animals with an approved flea and tick product before allowing them to enter treated habitat.
