Dear Mr. Stratemeier:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following label revision provision(s):

General Comment(s):

1. The SAL for the subject product, dated June 16, 2010, approved a number of label changes including the addition of a requested ABN to read as follows: "Black Knight™ HABITAT™ TREATMENT Ant & Roach Killer," based on the fact that the existing label included the use pattern on snake mites in snake aquariums, habitats, or cages. Your recent submission, dated November 23, 2010, incorporates all of the label review comments from the referenced SAL, with the exception of the comment related to the snake mite use pattern. Since your company has decided to remove the snake mite use pattern from the subject label as part of your response to the SAL, you must also delete the newly approved ABN and revert back to the original main product name for this product, which reads "Black Knight™ Roach Killer." If the newly approved ABN were to remain on the subject product, this would be false and misleading to the consumer since the snake mite use pattern is no longer on the label.

A copy of your label stamped "Accepted with Comments" is enclosed for your records. Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. Allow treated habitat to dry before allowing pets to re-enter. Repeat as necessary. Do not spray animals. Replace bedding with clean, fresh bedding after treatment. Treat animals with an approved flea and tick product before allowing them to enter treated habitat.

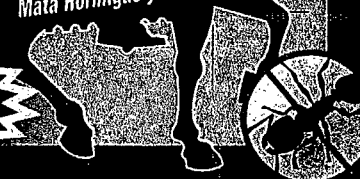
