The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

Because this amendment removes an unsupported use pattern, you may not distribute or sell this product bearing the previously approved labeling after the date you receive this letter.

In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

SHAKE BEFORE USE. HOLD CONTAINER UPRIGHT. APPLY IN SHORT BURSTS

Remove pets, birds and cover fish aquariums before spraying. **Do not use in aircraft cabins.**

RESTRICTIONS: FOR INDOOR USE ONLY. Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For spot spray, do not enter or allow others to enter until sprays have dried. For space spray, do not enter or allow others to enter until vapors, mists and aerosols have dispersed and the treated area has been thoroughly ventilated. Do not use in food areas of food handling establishments, restaurants, or other areas where food is commercially prepared or processed. Do not use in serving areas where food is exposed or facility is in operation. Serving areas are areas where foods are served such as dining rooms, but excluding areas where foods may be prepared or held. In the home, cover all food processing surfaces and utensils during treatment or thoroughly wash utensils before use. Cover exposed food and remove utensils in serving areas.

FOR SPACE SPRAY: To Kill Flies, Mosquitos, Small Flying Moths, Gnats and Wasps: Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Keep room closed for 15 minutes after spraying. Sweep up and destroy fallen insects. Do not enter or allow others to enter until vapors, mists and aerosols have dispersed and the treated area has been thoroughly ventilated.

FOR AIRCRAFT (Cargo storage areas only):

To kill flying insects (mosquitoes, houseflies and Caribbean Fruit Flies): Use while the aircraft is empty of passengers and on the ground prior to take off and after landing. Before takeoff and after loading of all cargo is complete, close all doors, hatches and ventilation openings. Turn off ventilation systems. Spray for 10 seconds (10 grams) per 1,000 cubic feet. Push button to spray. Move arm from side to side in a sweeping motion. After spraying is complete, open doors and hatches, turn on ventilation system and ventilate for 30 minutes with fresh air prior to boarding the aircraft with passengers. After landing, remove all passengers, close all doors, hatches and ventilation openings and reapply insecticide as instructed above.

IN BUILDINGS, VANS, SHIPS AND IN TENTAGE:

To Kill Flying Insects (Mosquitoes, Houseflies and Gnats): Close space to be treated. Release 3 feet from any surface, holding dispenser above the head. Spray for 10 seconds (10 grams) per 1,000 cubic feet. Keep treated area closed at least 30 minutes. Ventilate area before re-entry. Repeat as necessary.

FOR SPOT TREATMENT:

To Kill Cockroaches, Ants and Crickets: Contact as many insects as possible with the spray. Special attention should be paid to cracks, hidden surfaces under sinks, behind stoves and refrigerators and food storage areas.

To kill ants, treat doors, around window frames, ant trails and other areas of entry. Repeat as necessary.

To Kill Exposed Forms of Confused Flour Beetles, Saw-toothed Grain Beetle and Rice Weevils: Find and destroy infested package goods, and remove all other items from pantry. Spray the shelves to kill any of the listed insects present. Place clean paper on the shelves and return packages after shelves have dried. Repeat as necessary.

To Kill Sowbugs, Centipedes, Silverfish, Firebrats and Spiders: Contact as many insects as possible with the spray. Special attention should be paid to cracks, crevices, hidden surfaces under sinks, behind stoves and refrigerators.

To Kill Fleas and Brown Dog Ticks: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and local areas of floors. Repeat as necessary. Do not spray animals. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Also, treat dogs and cats with a registered flea and tick control product before allowing them to enter treated area. Allow treated surfaces to dry before permitting pets to re-enter the treated area.

FOR CRACK AND CREVICE: To Kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas and Carpet Beetles: Apply spray in small amounts directly into cracks and crevices. Equipment capable of delivering a pin stream should be used for points between different elements of construction, between equipment and floors, openings leading to voids, hollow spaces in walls, equipment legs and bases where listed insects hide.
