



DIRECTIONS FOR USE

OVERALL LAWN APPLICATION

Pratt Diazinon 5% Granules control the following lawn insects on both grass and dichondra lawns: Chinch Bugs, Earwigs, Ticks, Ants, Lawn Moths (Sod Webworms), Bermuda Mites, Crickets, Armyworms, Brown Dog Ticks, Chiggers, Clover Mites, Cutworms, Fleas, Leafhoppers, Sowbugs, Millipedes, Springtails (Collembola). Apply Pratt Diazinon 5% Granules to your lawn with a fertilizer spreader with the setting to give the rates required. Application should be made when grass is dry. Water lawn lightly after application. Repeat as necessary.

Apply at the rate of 2 lbs. per 1000 sq. ft. (an area 20 ft. by 50 ft.) or 3.2 oz. per 100 sq. ft. (an area 10 ft. by 10 ft.). For heavy lawns such as St. Augustine lawns, application should be increased to 3 lbs. per 1000 sq. ft. (or 4.8 oz. per 100 sq. ft.).

Billbogs and White Grubs of Japanese Beetle, European Chafer, Southern Chafer: Apply 2.4 lbs. per 1000 sq. ft. of lawn, Water grass thoroughly after application. For grub control make application any time between late July and early October. For billbug control apply when activity is first observed or when chewed or brown grass indicates damage for these insects. Repeat

Hyperodes Weevel (New York only): Apply 2 lbs. per 1000 sq. ft. of grass. Water grass thoroughly after application. Treat probdem areas in mid-April and again in mid-May.

SPOT TREATMENT

Ants: Apply one teaspoon of Pratt Diazinon 5% Granules over and around each individual ant hill.

Digger Wasps Apply one teaspoon of Pratt Diazinon 5% Granules in and around each individual ground nest opening. Make the application about dusk when the wasps are not active.

BANC TREATMENT AROUND FOUNDATION

The following insects are commonly found around or near the foundation of houses as well as in the lawn. Certain of these insects may even enter the house: Ants, Brown Dog Ticks, Clover Mites, Crickets, Earwigs, Fleas, Millipedes, Sowbugs, Spri & tails (Collembera). For control of the above insects, apply a 5 ft. band of Pratt Diazinon 5% Granules next to the founds: of the house. Discribute the granules uniformly, using a rate of 3.2 oz. for each 5 ft. by 20 ft. area to be treated.
