



**DIRECTIONS FOR USE IN  
FOOD HANDLING ESTABLISHMENTS**

**USE IN FOOD HANDLING ESTABLISHMENTS:** Places other than private residences in which exposed food is held, processed, prepared or served.  
**FOOD AREAS — APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY.** Includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing) preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation also would be considered a food area).

Apply in small amounts directly into cracks and crevices using equipment capable of delivering a pin stream in points between different elements of construction, between equipment and floors, openings leading to voids and hollow spaces in walls, equipment legs and bases, conduits, motor housings, junction or switch boxes, where Roaches, Ants, and Waterbugs hide.

Prior to application de-energize electrical equipment. After application, allow time for oil to evaporate before starting motors or placing switches in "on" position.

**APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.**

**SERVING AREAS:** Facilities where prepared foods are served, such as dining rooms, but excluding areas where foods may be prepared or held.

Apply as a spot treatment to selective surfaces such as baseboards, under elements of construction into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.)

**NON-FOOD AREAS:** Includes garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Apply to baseboard areas, around water pipes, surfaces behind and beneath sinks, lockers, tables, pallets and similar areas where insects hide or through which they may enter.

**HOW TO USE:** B.G.N. Household Insect Spray is ready to use as it comes from the can, and may be applied with either hand sprayers. Apply as a coarse spray to infested surfaces using the spray stream rapidly enough to prevent excess runoff and waste of material. Direct spray away from people.

**RESTRICTIONS:** Do not apply to rugs, carpets, drapes or similar materials that may be stained. Avoid excess spray on rubber and asphalt surfaces such as tiles and floor coverings. Do not use the small, finger-operated, plastic attachment type of B.G.N. Insect Spray solution for extended periods as the material may be damaged.

*VIII* **OUTDOOR USE:**

**ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEA BEETLES, AND BROWN DOG TICKS:** Spray infested areas on outside surfaces of screens, doors, window frames, and other places where insects may enter. For ants, spray in cracks and crevices. Repeat as necessary. Do not spray vegetation.

**INDOOR USE:**

**ANTS, COCKROACHES, CRICKETS, SILVERFISH, SAW-TOOTHED GRAIN BEETLES (EXPOSED STAGE)**

Spray into cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinet doors, stoves, and in and around waste containers. Repeat as necessary. Do not spray foodstuffs or house plants. For ants, spray in cracks and crevices. Do not allow children to contact surfaces until surfaces are thoroughly dry.

**BROWN DOG TICKS:** Spray sleeping quarters of pets in window and door frames, wall cracks, and local areas where ticks are likely to hide. Fresh bedding should be placed in animal quarters. Do not spray animals.

Direct spray away from people, plants, and pets.

**RESTRICTIONS:** Do not apply to rugs, carpets, draperies, wallpaper, or similar materials that may be stained. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tiles and floor coverings. Do not allow the small, finger-operated, plastic attachment type sprayer to remain in B.G.N. Insect Spray solution for extended periods as the plastic sprayer may be damaged.

### *V.I.I. OUTDOOR USE: X.I.I. outdoor use*

**ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEAS, MILLIPEDES, SOW-BUGS, AND BROWN DOG TICKS:** Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. Repeat as necessary. Do not spray vegetation.

### INDOOR USE:

**ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SCORPIONS, SAW-TOOTHED GRAIN BEETLES (EXPOSED STAGE), WATERBUGS:**

Spray into cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Repeat as needed. Do not spray foodstuffs or house plants. For ants, spray trails and places where ants enter premises. Do not allow children to contact treated areas until surfaces are thoroughly dry.

**BROWN DOG TICKS:** Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.
