

#### DO NOT USE ON LAWNS

PRATT'S NS WEED KILLER is for non-selective weed and grass control in driveways, parking lots, storage areas, and industrial areas where a weed free soil surface is desired. This product kills most young weeds and grasses on contact and deposits a chemical residue on the soil. This residue prevents annual weeds and grass seeds from growing during the entire growing season. Contact activity will be apparent in a few days. Final kill by root penetration may take from 2 to 3 weeks. The effectiveness and length of time that control will last will depend on type of soil, amount of rain, and other conditions.

#### DIRECTIONS FOR USE

For best results apply in early Spring before weeds germinate or when weeds are small. Under extreme conditions a second application may be required. Application may be made when top growth is dense, but better control will be obtained when weeds are short or when excess growth is mowed and removed before applying.

For driveways, graveled areas, parking lots and storage yards: Mix 1 quart weed killer with 2 gallons of water and apply evenly over 125 sq. ft. Use a sprinkling can or coarse sprayer to thoroughly wet all foliage.

For areas where heavy grass and weed growth is present such as fence rows and fire lanes and where vegetation is more than 18 inches high: Apply 1 quart in 5 to 8 gallons of water per 125 sq. ft. Under conditions where weeds are difficult to control increase the rate of application to 2 to 3 quarts in 4 gallons of water per 125 sq. ft.

**PRECAUTIONS:** Do not use this product on lawns. Do not apply over root zones of valuable trees, shrubs, or woody ornamental plants.
