DIRECTIONS FOR USE

(After application wash granules into soil with 30 gallons of water per 1,000 sq. ft.)

CHINCH BUGS, SOD WEBWORMS, ANTS, CRICKETS, CUTWORMS, EARWIGS, SOWBUGS: Spread uniformly at a rate of 1 pound per 1,000 sq. ft. In northeastern states, make first application in May or June or when insects first appear. Re-treat as needed, usually in July or August.

HYPERODES WEEVILS: Apply uniformly at a rate of 2 pounds per 1,000 sq. ft. Make the first application of suspected area in mid-April, followed by second application 30 days later.

BROWN DOG TICKS: Apply uniformly at a rate of 1 pound per 1,000 sq. ft., with special attention to pet resting areas.

Harmful if swallowed. May be absorbed through skin. May be injurious to eyes and skin. Do not get on skin or in eyes. Flush contaminated eyes with plenty of water and get medical attention. Wash thoroughly after handling. Do not wear contaminated clothing. Keep away from food, feedstuffs and domestic water supplies. Do not graze animals on treated areas.

NOTE TO PHYSICIAN: Active ingredient is a cholinesterase inhibitor. Treat symptomatically. Atropine is an antidote.
