

DIRECTIONS FOR USE

HOW TO USE

SHAKE BEFORE USING. Read entire label, noting all cautions and precautions. This product is ready-to-use. Adjust nozzle to coarse spray or fine stream, depending on the type of coverage desired.... Point nozzle away from face and spray infested surface until wet.

TO CONTROL ANTS, BOXELDER BUGS, CENTIPEDES, ROACHES, CRICKETS, EARWIGS, PALMETTO BUGS, PILLBUGS, SCORPIONS, SILVERFISH, SPIDERS, SPIDER BELTLES, WATERBUGS: Spray areas where these pests are found or may hide, including dark corners of rooms, closets, cracks, crevious, along baseboards, door sills and frames, behind and beneath sinks, stoyes, refrigerators, cabinets and around garbage cans, plumbing and other utility areas. Pests flushed out of hiding should be sprayed directly.

To Control Ants:

Treat ant trails, nests and points of entry. Repeat treatment as necessary.

TO CONTROL BROWN DOG TICKS: Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows and door frames, wall and floor coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. DO NOT TREAT ANIMALS WITH THIS FORMULATION.

TO CONTROL CARPET BEETLES, CIGARETTE BEETLES, CLOTHES MOTHS: Spray under and around edges of carpeting, rugs and closets. Also apply to floors and baseboards. Spray directly into cracks, crevices, closets and infested areas of shelving and/or wherever these insects are seen or suspected. Repeat as necessary.

TO CONTROL FRUIT FLIES, GNATS, HOUSE FLIES, MOSQUITOES, SMALL FLYING MOTHS: For cutdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

TO KILL FLEAS AND BROWN DOG TICKS, INDOORS: Clean premises thoroughly before treatment. Spray an inconspicuous area of furniture, carpet or flooring to check for possible staining or discoloration. Using a coarse spray, treat the entire floor and carpet area. Special attention should be given to cracks, crevices and under carpet and rug edges. Also treat closets, upholstered furniture (with particular attention to seams), under sofas and other furniture. Do not use this product in nurseries or any area where infants may sleep.
