HAZARDS TO HUMANS AND DOMESTIC ANIMALS

STATEMENT OF PRACTICAL TREATMENT

IN CASE OF CONTACT, wash skin with soap and water. For Eyes: Flush with plenty of water and get medical attention. If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person. NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine, by injection only, is antidotal.

This pesticide is extremely toxic to fish, birds and other wildlife. Do not apply directly to water. SHAKE WELL BEFORE USING

LAWNS AND TURF: To control Ants, Armyworms, Billbugs, Brown Dog Ticks, Chinch Bugs, Clover Mites, Crickets, Cutworms, Earwigs, Flea Beetles, Fleas, Grasshoppers, Sod Webworms (Lawn Moths), and Vegetable Weevils infesting dichondra and grass lawns, mix ACT-PLUS LAWN INSECTICIDE with water according to the directions given in the following table and apply as a coarse droplet spray using a low pressure tank sprayer or hose attachment sprayer. For best results the lawn should be moist at the time of application and care should be taken to obtain complete and uniform coverage of infested areas. Spray when pests first appear and re-treat when needed.

500 sq. ft.	9 tablespoons (4 1/2 fl. ounces)	15 gallons
1000 sq. ft.	18 tablespoons (9 fl. ounces)	30 gallons
1500 sq. ft.	27 tablespoons (13 1/2 fl. ounces)	45 gallons

FOR CONTROL OF BILLBUGS

Area to be treated	Amount of ACT-PLUS LAWN INSECTICIDE	Dilute with water to make
500 sq. ft.	3/4 - 1 1/2 cups (6 - 12 fl. oz.)	15 gallons
1000 sq. ft.	1 1/2 - 3 cups (12 - 24 fl. oz.)	30 gallons
