## **PRECAUTIONARY STATEMENTS**

### **HAZARD TO HUMANS AND DOMESTIC ANIMALS**

#### **DANGER**

**CORROSIVE. CAUSES EYE AND SKIN DAMAGE. IRRITATING TO NOSE AND THROAT. HARMFUL OR FATAL IF SWALLOWED.**

#### **PHYSICAL OR CHEMICAL HAZARD**

**STRONG OXIDIZING AGENT.** Contact with water slowly liberates irritating and hazardous chlorine containing gases. Decomposes at temperatures above 464°F with liberation of harmful gases. When ignited, will burn with the evolution of chlorine and equally toxic gases.

**NEVER** add water to product. Always add product to large quantities of water. Use clean, dry utensils. **DO NOT** add this product to any dispensing device containing remnants of any other product. Such use may cause a violent reaction leading to fire or explosion. ## **STORAGE AND DISPOSAL**

**STORAGE:** Keep material dry and in a dry area. Store in original container where temperatures do not exceed 125°F (52 °C) for 24 hours. Retie polyethylene liner after each use and keep container tightly closed.

**PESTICIDE DISPOSAL:** Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. Labeling:

1. The signal word is "Danger".

2. The Precautionary Statements should read:

"Corrosive: Cause irreversible eye damage. May be fatal if inhaled. Harmful if swallowed or absorbed through skin. Do not get in eyes, on skin or on clothing. Do not breathe dust, vapor or spray mist. Wear goggles, face shield or safety glasses. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse".

3. The Statements of Practical Treatment should read:

"If in eyes: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention".

"If inhaled: Remove victim to fresh air. If not breathing, give artificial respiration preferably mouth-to-mouth. Get medical attention".

"If on Skin: Wash with plenty of soap and water. Get medical attention if irritation persists".

"If swallowed: Drink promptly large quantities of water. Avoid alcohol. Note to physician: Probable mucosal damage may contraindicate the use of gastric lavage. Get medical attention".
