DIRECTIONS

ROACHES, WATER BUGS, SILVERFISH, SPIDERS AND CENTIPEDES are controlled by spraying directly on these insects whenever possible and in areas where these insects are found, such as under sinks, drainboards, cabinets, in back of, under and between refrigerators and stoves, cracks and crevices around baseboards, pipes, bookcases, storage areas, floor coverings and certain other areas. Repeat treatment as necessary.

BEES AND HORNETS: This product is not recommended for direct application at bees or hornets because of the possibility of being stung. It is intended for use to wet spray directly on their honeycomb nests. It has a jet stream range of over 5 feet. The best time for treatment is in the evening when the insects are at rest.

CAUTION

DO NOT SPRAY NEAR OPEN FLAMES. Avoid contamination of foodstuffs. Foods should be removed or covered during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in these areas, apply only when processing is not in operation. Harmful if swallowed.
