**LEBANON ROSE SPRAY** controls Aphids, Mites, Thrips, Japanese Beetle, Rose Chafer, Black Spot and Rust.

**ROSES:**  
Mix 2 level tablespoonfuls per pint of water (16 tblsp. per gallon). Begin application as soon as leaf growth begins and every 7 to 10 days until foliage drops. Spray promptly after every rain regardless of the length of time since your previous application.

**FLOWERS: CARNATIONS, DAHLIAS, GLADIOLUS, SNAPDRAGON and ZINNIA**  
Mix 2 level tablespoonfuls per pint of water (16 tblsp. per gallon). Spray every 7 to 10 days during growing season.

**NOTE:** Do not use on Boston, Maidenhair or Pteris Ferns, as well as species of Crassula. Do not apply to Petunias.

**CAUTION**
