

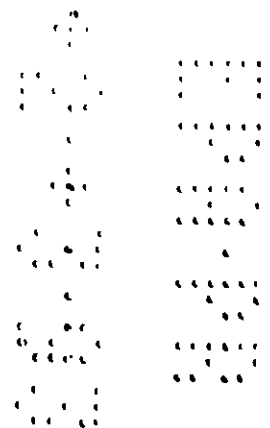

1. Measure lawn area to be treated. Apply evenly at a rate of one bag for each 10,000 sq. ft.
2. **IMPORTANT:** Apply when grass is moist (after a rain, sprinkling or dew). Do not water lawn after material is applied. Water will wash off weed-killing material.

NOTE: May damage bentgrass, carpetgrass, centipedegrass, clover, dichondra and St. Augustinegrass -- Also, grass seedling on a newly-seeded lawn.

3. For most effective broadleaf weed-killing action, avoid unnecessary disturbance of treated areas for 48 hours after application.
4. Avoid contact with valuable shrubs, plants or flowers. Vapors from this product may injure susceptible plants in the immediate vicinity. Do not contaminate water used for domestic or irrigation purposes.
5. The maximum number of broadcast applications per treatment site is two per year.
6. Sweep all fertilizer materials from concrete surfaces immediately after application. Do not wash materials from concrete surfaces because some fertilizers may contain iron which may cause discoloration upon oxidization.
