HOW TO USE

1. This product fertilizes grass and controls smooth and hairy crabgrass, goosegrass, barnyardgrass, green and yellow foxtail and annual bluegrass on established turf of Bluegrass, Ryegrass, Fescue, Bahiagrass, Bermudagrass, Centipedegrass, St. Augustinegrass, Zoysiagrass.
2. Do not apply in the spring to Bluegrass planted the previous fall. Do not apply to newly sprigged areas until root growth is established.
3. Apply this product in early spring prior to weed grass seed germination at the rate of 275 lbs. (2# actual benefin) per acre. An early fall application is also effective for control of poa annua (annual bluegrass) at the same rate.
4. Reseeding should be delayed approximately 90 days after using benefin.

CAUTION

Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes.
