The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

- Revise the oral statement in the Statement of Practical Treatment to read "IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting."
- 2) Revise the second sentence of the dermal statement in the Statement of Practical Treatment to read "Get medical attention if symptoms persist."
- 3) Revise the inhalation statement in the Statement of Practical Treatment to read "IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention."

A stamped copy is enclosed for your records. Please submit one (1) final printed copy for the referenced label, incorporating the above changes, before releasing the product for shipment.

ENTRY RESTRICTIONS

Do not allow people or pets to enter the treated area until dusts have settled. If watering in is required after the application, do not enter or allow others to enter the treated areas (except those involved in the watering) until the watering-in is complete and the surface is dry.

GENERAL INFORMATION

This turf fertitizer product contains TEAM, a preemergence herbicide which is applied to established turfgrasses for the control of the winter annual grass: Annual Bluegrass (*Poa annua*); and summer annual grasses: Smooth and Hairy Crabgrass, Goosegrass (silver crabgrass or crowfootgrass), Barnyardgrass (watergrass) and Green and Yellow Foxtail. This product also provides partial control of Prostrate Spurge (*Euphorbia humistrata*), Spotted Spurge (*Euphorbia maculata*), Creeping Spurge (*Euphorbia serpens*), Creeping Woodsorrel (*Oxalis corniculata*) and Yellow Woodsorrel (*Oxalis stricta*).

Use caution to confine product to intended application area, as the active ingredients may stain concrete, plastic or other materials.

Do not apply this product to golf course putting greens, dichondra, or newly sprigged areas of Bermudagrass, St. Augustinegrass, Centipedegrass or Zoysiagrass. Any cultural practices that disturb the soil, such as aerification or verticuting, should be done prior to application.

APPLICATION

This product should be applied one to two weeks prior to the anticipated germination of the target annual weeds. Apply using a properly calibrated granular fertilizer spreader which will uniformly distribute the product over the target area. Avoid skips and excessive overlaps as poor weed control or turfgrass injury may occur. Optimum weed control performance will be obtained if treated areas are irrigated soon after application. This product will not harm most nearby ornamentals.

In areas with extended growing seasons or where desired, a second application at the recommended rate can be made 8 to 10 weeks following the initial application on cool season turigrasses and 10 to 12 weeks following the initial application on warm season turigrasses.

WHEN TO APPLY

All of the Summer annual grasses do not germinate at the same time. If application timing does not coincide with the normal germination period of any of the annual grasses weeds listed on this label, weed control results may be erratic or poor.

Any cultural practices that disturb the soil, such as aerification or verticutting, should be done prior to application.

1. Spring germinating Summer annual grasses - Crabgrasses, Foxtails and Barnyardgrass

Northern (cool season) turigrasses:

For preemiergence control, apply 3 lbs. per 1,000 sq. ft. (2 lbs. active ingredient per acre) in the Spring one to two weeks prior to the onset of conditions favorable for annual weed grass seed germination.

Southern (warm season) turfgrasses:

For preemergence control, apply 3 to 4.5 lbs. per 1,000 sq. ft. (2 to 3 lbs. active ingredient per acre) in the late Winter or early Spring one to two weeks prior to the object of conditions favorable for annual weed grass seed germination.

In areas of the United States where germination of the annuaged grass species continues for extended periods of time, a seweeks after initial treatment for continued control.

2. Late Spring, early Summer germinating annual grasses - Goosegrass

Although classified as a Summer annual grass, goosegrass normally germinates 4 to 6 weeks later than cratigrass, forcalls and other Summer annual grass species. Applications should, therefore, be timed accordingly.

Northern (cool season) turfgrasses:

For preemergence control, apply 3 lbs. per 1,000 sq. ft. (2 lbs. active ingredient per acre) in the late Spring or early Summer one to two weeks prior to the expected germination of goosegrass. Southern (warm season) turtgrasses:

For preemergence control, apply 3 to 4.5 lbs. per 1,000 sq. ft. (2 to 3 lbs. active ingredient per acre) in the less Spring or early Summer one to two weeks prior to the expected germination of goosegrass.

NOTE: Northern and Southern Turfgrasses - In areas of the United States where preemergence control of both early germinating annual grasses (crabgrass, foxtails and barnyardgrass) and the later germinating goosegrass is desired, two applications at the recommended rate spaced 8 to 10 weeks apart may be made to provide full season control of these annual grass species.

3. Poa Annua (annual bluegrass)

in areas of heavy infestation of annual bluegrass, its elimination will temporarily result in thin turfigrass areas. The fertilizer component of this product will encourage the existing turfgrasses to fill in these thin areas previously occupied by annual bluegrass.

Northern (cool season) turfgrasses:

For preemergence control, apply 3 lbs. per 1,000 sq. ft. (2 lbs. active ingredient per acre) in late Summer or early Falland again in late Winter or Spring one to two weeks prior to the expected germination of annual bluegrass.

Southern (warm season) turfgrasses:

For preemergence control, apply 4.5 lbs. per 1,000 sq. ft. (3 lbs. active ingredient per acre) in the late Summer or early Fall one to two weeks prior to the expected germination of annual bluegrass. In southern areas of the United States where germination of annual bluegrass continues for extended pariods of time, a second application of 6 lbs. per 1,000 sq. ft. can be made 10 to 12 weeks after the initial treatment.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

STORAGE: Keep in original container in a cool, dry area, away from extreme heat and direct sunlight. Do not store near food, feed, seeds or other pesticides.

PESTICIDE DISPOSAL: Securely wrap unused product in several layers of newspaper and discard in trasta.

CONTAINER DISPOSAL: Do not reuse container. Discard container in trash.

RESEEDING

Chemicals that effectively control annual weed seeds may also affect new desirable turigrass seedlings. Researing should be delayed for a least 6 weeks after application. When reseeding, it is essential that proper cultural practices such as soil cultivation, irrigation and fertilization be followed. For satisfactory reseeding results, the amount of seed used should be increased, and equipment designed to place seed in contact with the soil should be employed. When using at the highest recommended rate, reseeding should be delayed 12 to 16 weeks after application.

HOW TO APPLY

For most effective annual weedgrass control, make application uniformly over your lawn area with no skips or misses: annual weedgrass will be uninhibited in untreated areas. Determine the correct amount of product for your lawn: 30 lbs. covers 10,000 sq. ft. (700 x 100 ft.); this is at the rate of 3 lbs. per 1,000 sq. ft. Do not over-apply or under-apply. Refer to the table below as a guide for setting your spreader. Settings may vary with lawn surface, individual spreaders and rate of walk. Check your spreader on a small area to be certain you are applying at the rate of 3 lbs. per 1,000 sq. ft.

These settings were calibrated and field tested. However, age and condition of spreader, speed of operation, and everness of terrain may require slightly different settings for desired coverage, 5 pz. per 100 sq. ft.

HELPFUL APPLICATION TECHNIQUES FOR APPLYING

When using a drop-type spreader, a splash board mounted under the hopper will help dispense granules more evenly

A chain fastened to the side of your spreader will leave a marked or scuffed turf area to follow and help prevent missed areas.

Early morning applications when the wind is calm and dew is on the ground are ideal. Wheel tracks are easy to follow and granules can be spread uniformly.

Small area application is easy using a small rotary applicator. To insure proper coverage and avoid missed areas, early morning treatment when wheel tracks are evident in the dew and the wind is calm are ideal.

PRECAUTIONS

Apply this product to the turf prior to the germination of weed grasses, since it will not control established weeds. Do not apply in the Spring to turfgrasses planted the previous Fall. In; '''''' Bermudagrass areas that have been overseeded with Winter grasses, a Spring application may thin the overseeded grasses. Do not apply to bentgrass, putting greans or dirhondra, for to neutry-springed areas of Bermudagrass, St. Augustinegrass or Certificedegrass until these turfs are well established.
