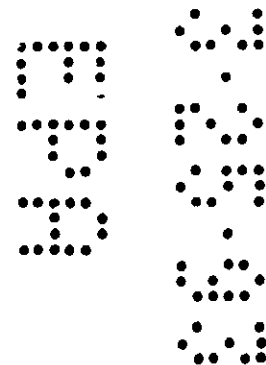

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

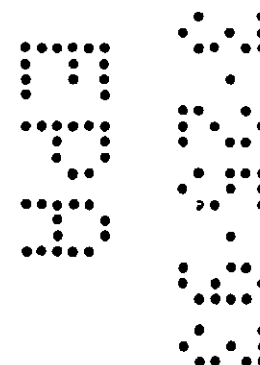

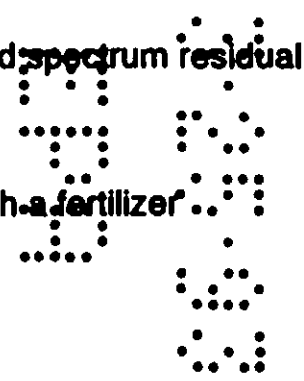

Lebanon Fertilizer with TURCAM is a combination fertilizer and broad spectrum residual insecticide for the control of certain insects on turf.

Application Equipment:

Lebanon Fertilizer with TURCAM is a granular formulation. Apply with a fertilizer spreader or equivalent equipment as uniformly as possible.

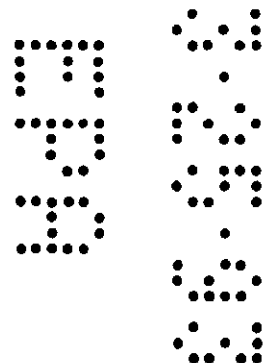


DIRECTION FOR USE

TURF RECOMMENDATIONS (Home Lawns Only):

Use Lebanon Fertilizer with TURCAM to control specified pest to turf. Apply to give complete and uniform coverage of the pest-infested areas. Applications should be made using the rates shown below:



Pest	Dosage of Product	Application Procedure
White grubs of: Japanese beetle, Black turf grass Ataenius, European chafer, Northern masked chafer, Green June beetle, Annual white grub, Mole crickets.	3.8 - 5.6 lbs. per 1,000 sq. ft. (160-240 lbs. per acre)	Apply when pests become evident. Control of grubs is best when they are still small; therefore, late summer treatments are preferable to spring. Apply uniformly to assure coverage. In order to improve efficiency, irrigate as soon as possible with 1/4 to 3/4 inch of water.
Chinch bugs, Leafhoppers, Sod webworms, Ants, Bees, Brown dog ticks, Centipedes, Crickets, Earwigs, Firebrats, Fleas, Ground beetles, Millipedes, Pillbugs, Scorpions, Silverfish, Sowbugs, Spiders, Wasps.	1.9 - 3.8 lbs. per 1,000 sq. ft. (80-160 lbs. per acre)	Apply when pests are evident. Use adequate quantities of water to thoroughly moisten grass and thatch.
