Dear Freddy Shelley:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

The Agency, in accordance with FIFRA, as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Mecoprop-p Interim Decision. The Agency has concluded that your submission is acceptable.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. *The next label printing of this product must use this labeling unless subsequent changes have been approved.* You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. “To distribute or sell” is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) lists examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance.

Your release for shipment of the product constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6.

HERBICIDE RESISTANCE MANAGEMENT

For resistance management, TURF Fertilizer Plus Trimec® Ester Weed Control is a Group 4 herbicide. Any weed population may contain or develop plants naturally resistant to TURF Fertilizer Plus Trimec® Ester Weed Control and other Group 4 herbicides. The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same field. Appropriate resistance management strategies should be followed.

To delay herbicide resistance, consider the below best practices for resistance management:

- Rotate the use of TURF Fertilizer Plus Trimec® Ester Weed Control or other Group 4 herbicides within a growing season sequence or among growing seasons with different herbicide groups that control the same weeds in a field.
- Use tank mixtures with herbicides from a different group if such use is permitted; where information on resistance in target weed species is available, use the less resistance-prone partner at a rate that will control the target weed(s) equally as well as the more resistance-prone partner. Consult your local extension service or certified crop advisor if you are unsure as to which active ingredient is currently less prone to resistance.

TURF Fertilizer Plus Trimec Ester Weed Control contains Trimec® Herbicide. Trimec® controls a wide range of lawn weeds, including dandelion, chickweed, plantain, henbit, spurge, and many

other listed weeds commonly found in home lawns. In addition, a xx-xx-xx fertilizer provides a supply of lawn food. Possible retreatment may be necessary if (a) the lawn is heavily overrun by weeds or, (b) if adverse low moisture conditions prevail and weeds are in a state of poor growth. A second application may be made after 30 days. Treated areas may be seeded 3 weeks after application.

AGRICULTURAL USE REQUIREMENTS

The maximum number of broadcast applications is limited to 2 per year with a minimum of 30 days between applications. The maximum seasonal rate is 8.0 pounds of product per 1,000 sq. ft. (2.56 lbs. 2,4-D ae, 0.58 lb. MCPP-p ae and 0.25 lb. dicamba ae per acre).]

2. Water lawn thoroughly at least 1 to 2 days before application to sustain moisture until the next watering (see step 5).
3. Apply when weeds are young and actively growing, preferably in the morning when the dew is on the grass. If grass is not moist at time of application, sprinkle lightly with water before applying product.
4. Avoid applying when temperatures are consistently above 90°F.
5. **DO NOT** wash from weed leaves for 1 to 2 days after application. At this time, a thorough watering should be made.

(Steps 1-5) – OPTION B:

1. Mow lawn to normal height, 1 to 2 days before application.
2. For best results lawn must be MOIST and the air calm, when product is applied. When the lawn is moist, the product granules stick better to the leafy parts of the weeds, ensuring that the weed-killing ingredients are absorbed by the weed plant.

TIP: Apply after a heavy dew or rain, or on a thoroughly watered lawn.

TIP: DO NOT apply to a moist lawn **IF** rain is expected within 24 hours of application.

TIP: DO NOT water in immediately after application as the granules need to stick to the weed plant leaf for 1-2 days to be most effective.

3. Apply when weeds are young and actively growing.

4. Avoid applying when temperatures are consistently above 90°F.
5. After a 1-2 day period after application, if it has not rained – the lawn should be thoroughly watered.
