Mice: For house mice, place 1/2 to 1/3 of contents of one Place Pack (3 to 7 oz.) per bait placement. Bait placements should be 8 to 10 feet apart near runways, burrows or feeding areas. For outdoor use, protect bait from rain or snow. Check stations daily and provide an uninterrupted supply of bait until all signs of feeding stop.
